# Energy Alterations in Patients that are Presenting Elevation of D-Dimer after Receiving the COVID-19 Vaccine

#### ABSTRACT

Introduction: D-dimer is a product of blood clots. The purpose of this study is to demonstrate that patients with high D-dimer after receiving the COVID-19 vaccine have energy deficiency inside the five internal massive organs responsible for the production of internal energy allowing the blood to flow inside the blood vessels. The use of highly concentrated vaccines such as the COVID-19 vaccine will cause a drop even more in these energies, which is already very low, and cause Blood stagnation causing an increased chance to form a blood clot, increasing the D-dimer.

**Methods:** two case reports of a 72 and 70 years-old female patient with a history of receiving three and two doses of COVID-19 vaccine respectively. The first patient did the D-dimer exam three months after the third dose of the COVID-19 vaccine which revealed that it was three times above the normal exam. The second patient was presenting small purplish spots on the arms after 4 months of the second dose of COVID-19 vaccine and the D-dimer was a little above normal value. They both received the measurement of the energy of the five internal massive organs using the radiesthesia procedure.

**Results:** all internal five internal massive organs were in the lowest level of energy, rated one out of eight. The treatment of their condition using Chinese dietary counseling, auricular acupuncture with apex ear bloodletting, and replenish the energy of these organs using highly diluted medications according to the theory of *Constitutional homeopathy of the Five Elements Based on Traditional Chinese Medicine* and crystal-based medications was important to replenish of all these organs and increase the production of internal energy responsible for the Blood flow inside the Blood vessels. **The conclusion of this study** is to demonstrate that patients with high blood D-dimer after receiving the COVID-19 vaccine have in common, energy deficiency inside the five internal massive organs, and the treatment of this condition rebalancing the internal organs energy using Chinese dietary counseling, auricular acupuncture, and with apex ear bloodletting and systemic acupuncture and replenishing the energy of these organs using highly diluted medications according to the theory of *Constitutional Homeopathy of the Five Elements Based on traditional Chinese Medicine* and crystal-based medications to improve the energy of all these organs to produce internal energy to allow the blood flow inside the blood vessels to prevent the formation of the blood clot, that it is causing the increase in D-dimer in the energy level.

#### Introduction

D-dimer is a product of the blood clot. Platelets in the blood are connected to D-subunit. When there is an occurrence of a blood clot, the D group of the platelets forms o bond, and many platelets bonds together via the D-dimer [1].

There are some studies in the literature showing the increased chance to have blood clots after receiving the COVID-19 vaccine such as the study written by Mani and Ojha (2022) titled *Thromboembolism after COVID-19 Vaccination: A Systematic Review of Such Events in 286 Patients* [2].

The purpose of this study is to demonstrate that patients with high D-dimer after receiving the COVID-19 vaccine have energy deficiency inside the five internal massive organs of the five elements theory of traditional Chinese medicine (Liver, Heart Spleen, Lungs, and kidney) and the treatment of this condition of energy deficiency situation is of paramount importance to treat the cause of blood clot formation and not just treating the symptoms, that it is the formation of blood clot itself.

#### Methods

Through two case reports. Both give their consent to publish their history in this article.

#### **First Case Report**

The first is a 76 years-old female patient that received three doses of the COVID-19 vaccine. Three months after the third dose, I decided to measure the D-dimer to see if her exams were all right. The result was that the D-dimer was 1500 ng/ml being the normal value until 500 ng/ml. She did not suffer anything at that moment. I measured the energy of her five internal massive organs using a crystal pendulum in a procedure called radiesthesia.

#### Second Case Report

The second patient was a 75 years-old female patient with a history of low back pain and she was doing acupuncture to relieve the pain. She said on January 2023 that it was appearing small purplish spots on the arms 4 months after receiving the second dose of COVID-19 vaccine; I asked her to measure the D-Dimer and it was a little above normal values (650 ng/ml, and the normal value was 500 ng/ml). I decided to measure the energy of the five internal massive organs.


#### Results

All internal organs' energy was at the lowest level of energy of both patients, rated one out o eight. The treatment of this condition was divided into three steps. The first was changing the dietary aspects of the patient orientating them to avoid the ingestion of dairy products, raw foods, Coldwater, and sweets (as these foods can reduce even more the energy of Spleen and pancreas energy, leading to less absorption of nutrients and less formation of Blood).

The second group of foods that I usually orientate them was to avoid the ingestion of coffee, soft drinks, and matte tea (because all these drinks could reduce the energy of the Kidney, which is important to the production of *Yin* and *Yang* energy).

The third group of foods to orientate was to avoid the ingestion of fried foods, eggs, honey, coconut, alcoholic beverages, melted cheese, and chocolate (because all these foods can cause imbalances of the Liver and Gall bladder and can cause more formation of internal Fire, and the meaning of all these energy imbalances I will explain in the discussion section).

The second step in their treatment was to do auricular acupuncture with apex ear bloodletting and systemic acupuncture, as I am showing the auricular points used in this treatment in Figure 1.

It was used to replenish the energy of these organs using highly diluted medications according to the theory of *Constitutional Homeopathy of the Five Elements Based on Traditional Chinese Medicine* and crystal-based medications, as I am showing in Table 1.

#### Results

After these treatments, the first patient reduced her D-dimer to 490 ng/ml after two months of treatment and the second patient improved from the purples completely in her arms but the exam to see if her exam normalized after the treatment was not ready until the end of writing this publication but both are still using the highly diluted medications showed above for their entire life, due to the contamination of the electromagnetic radiation of the modernization of telecommunication, leading to a reduction in their vital energy.

#### Discussion

There are studies in the literature showing an increased incidence of thrombosis after receiving the COVID-19 vaccine [3].

As said by Hippocrates (460 BCE - 375 BCE), the father of medicine, "it is more important to know which type of patients we are treating nowadays than to know which type of disease the patient has" [4].

Another oath said by Hippocrates (460 bce - 375 bce) is that "it is more important to consider other ancient medical traditions prior to the knowledge we have nowadays" [4].

For this reason, I will use the reasoning used by traditional Chinese medicine, to understand what are the energy alterations that are behind all patients that are having high D-dimer after receiving the COVID-19 vaccine [5].




Figure 3: The tree metaphor shows the different viewpoints between Western and traditional Chinese medicine

I usually use the tree metaphor to show the different viewpoints between Western and traditional Chinese medicine, to you to understand what it is the point that I want to show you for understand the energy alterations involved in patients with high D-dimer after receiving the COVID-19 vaccine, as you can see in Figure 3 [5].

We can divide this tree into two parts, the part under the earth and the part above the earth. The part above the earth is composed of a trunk with several branches. Each branch means one medical specialty and coming out of each branch, you can see many leaves. Each leave means one symptom or disease treated by each medical specialty. For example, myocardial infarction is a "leaf" level of the cardiology branch [6, 7].

The part above the earth is what Western medicine is focusing on nowadays, treating the "leaf" of each specialty [8, 9].





Figure 4: Yin and Yang symbol

According to traditional Chinese medicine, each symptom has a cause, not in the "leaf" of the tree but they understand that the cause of all disease formation, independently of whether it is emotional or physical symptoms, they are at the "root" of the tree, that Western medicine is not studying nowadays, because this part is invisible by the naked eye. At the "root" of the tree, there are two theories that are the cornerstone of all treatments in traditional Chinese medicine, that is the *Yin* and *Yang* theory and the Five Elements Theory, shown in Figures 4, 5, and 6. **Figure 5:** *Yin* and *Yang* energy imbalances lead to clinical manifestation in the "leaf" level of the tree




Figure 6: Five Elements theory

To know which energy imbalances the patient is presenting at the first medical appointment, we can ask five main questions in all patients, as you can see in Table 2 [8].

of internal Fire

As Western medicine's medical faculty suffer changes in the curriculum, after the implementation of the Flexner report in 1910, they only considered "scientific" what could be proven by radiological or laboratory exams as I am showing the different phases of the development of diseases, shown in Table 3, [8].

In this Table 3, you can see that the progression from health to disease is divided into five phases, and the first three phases are characterized by energy imbalances but the laboratory exams are normal.

Only in phase four, there are alterations in the laboratory exams, and it is in this phase that it is occurring alterations in D-dimer when the patient takes the COVID-19 vaccine.

The alterations presented in patients nowadays, are related to energy deficiency inside the five internal massive organs, as I am showing in the article written by myself (2021) titled *Energy Alterations and Chakras' Energy Deficiencies and Propensity to SARS-CoV-2 Infection*, and in the second article also written by myself (2021) titled *Are We Vaccinating Immunocompetent or Immunocompromised People for COVID-19*? [10, 11].

In both articles, I am showing that the majority of all my patients were in the lowest level of energy in all five internal massive organs (Liver, Heart, Spleen, Lungs, and Kidney) before the pandemic and these alterations are caused by the exposition to electromagnetic radiation after the implementation of 4G and 5G technology, causing a diverse clinical manifestation in the "leaf" level of the tree, in any kind of specialty as you can see on Table 4.





Figure 7: Relationship between Yin, Yang, Qi, and Blood

To *Yin* and *Yang* flow inside the body, there is the necessity to have two other energies, which are Qi and Blood, as you can see in Figure 7. [7,9].

When there is energy deficiency in one or a combination of energy deficiencies between them, there is a formation of internal Fire, leading to clinical manifestations in the "leaf" level of the tree, such as diabetes, all kinds of infections such as community or hospital infections or even cancer, as you can see in Figure 8. [8, 9, 12, 13].

In the case of patients that are receiving the COVID-19 vaccine, the majority of them are in the lowest level of energy and can cause a drop of this energy, which was already very low before the pandemic, leading to a state of immune deficiency as shown in the article written by myself (2021) titled *Are We Vaccinating Immunocompetent or Immunocompromised People for COVID-19*? [5, 11, 14].

So, before materializing in alterations in the laboratory exams, the patient has in the background, energy deficiency that is leading to more propensity to have a blood clot and not just caused by the spike proteins presented in the vaccine [15].

There are other factors that can contribute to the development of blood clots in patients nowadays. All kinds of things that can reduce our vital energy, will have more chance to develop blood clots as I am showing in the article written by myself (2021) titled *Can Biomaterial Surgical Implants Influence the Body's Health*? And in the second article also written by myself (2021) titled *How is the Mechanism of Immunodeficiency Caused by Metallic Implants and What Can they Cause when Inside the Patient's Body*? [16, 17].

In both articles, I am showing that the implantation of these devices inside the body can reduce vital energy, which is already very low, and can cause complications such as severe depression, a tendency to have diabetes, hypertension, myocardial infarction, strokes, or even cancer, because all diseases have in common, energy deficiency inside the five internal massive organs [16].




Figure 9: Arndt-Schultz Law

The use of any kind of highly concentrated medications can cause the reduction of this vital energy and can worsen the energy of the patient or even lead to death, as I am showing in the Arndt-Schultz Law, which was created in 1888 by two German researchers, as you can see in Figure 9. [18].

I wrote some articles about the formation of thrombosis when using any kind of highly concentrated medications mainly in the treatment of COVID-19 patients, as I am showing the evolution of myocardial infarction without arterial obstruction in patients using highly concentrated medications in this treatment reducing the vital energy and causing Blood stagnation in the coronary artery [6].

In another article also written by myself (2022) titled *Energy Alterations in Patients with Pulmonary Artery Thrombosis After COVID-19 Treatment*, I am describing one female patient that evolved to pulmonary thrombosis weeks after receiving highly concentrated medications to treat this infection [19].

So, in this case, the use of the COVID-19 vaccine is also considered highly concentrated medication and can drop the internal energy, that it is compromised before the pandemic, and can cause diverse complications such as thrombosis, myocardial infarction, strokes, formation of cancer as I am showing in the article written by myself (2023) titled *Which Could Be the Risk Factors for Developing Cancer After Receiving The COVID-19 Vaccine*. [5-7].

For this reason, I wrote another article (2022) titled *Why is Highly Diluted Oral "Vaccine" For COVID-19 the Safest Option in this Pandemic?* to show that we need to use more highly diluted medications in this new type of population that we have nowadays. In all kinds of treatments, we need to know which type of population we have nowadays, to know which type of

medication or vaccine we need to use. This talk was presented at the International Conference on Vaccine Research (Vaccine Congress 2023), which was held on February 22, 2023. [14, 20].

In this case, the use of highly diluted medications, such as homeopathy, is the medication of choice to be used in the prevention and treatment of any kind of infectious and noninfectious diseases as I am showing in the article written by myself (2021) titled Why is Homeopathy the Medication of Choice in the Treatment of All Kinds of Diseases Nowadays? and in the second article also written by myself (2021) titled Why Homeopathy Is the Medication of Choice In The Prevention And Treatment of COVID-19 Infection? For this reason, in all these patients I am giving highly diluted medications according to the theory of Constitutional Homeopathy of the Five Elements Based on Traditional Chinese Medicine, where I am giving energy to all these organs to them work properly to produce Yin, Yang (by the Kidney), Blood( by the Spleen and controlled the Blood flow by the Heart), Qi (by the Liver and Lungs). The medications used to tone each internal massive organ are shown in Table 1, [21,22].

The use of any kind of highly concentrated medication including to treat the blood clot without treating the energy deficiency situation will drop even more vital energy, that it is reduced and can also cause complications or even death of these patients, as shown in many publications nowadays [23].




Figure 10: The metaphor of *Yin* and *Yang* of Western and traditional Chinese medicine

To understand what energy alterations the patients are having when presenting high D-dimer after receiving the COVID-19 vaccine, we need to integrate the reasoning used by traditional Chinese medicine, the oldest forms of medicine that exists for more than 5000 years, with the knowledge of Western medicine, that exists for 113 years (if we analyze after the implantation of Flexner report in 1910), as you can see in the metaphor of *Yin* and *Yang* of Western and traditional Chinese medicine, in Figure 10, [24].

The conclusion of this study is to show that patients with high D-dimer after receiving the COVID-19 vaccine have energy deficiency inside the five internal massive organs and the treatment of the cause using Chinese dietary counseling, auricular acupuncture, and apex ear bloodletting and systemic acupuncture and replenishing the energy of these organs using highly diluted medications according to the theory *Constitutional Homeopathy* of the Five Elements Based on Traditional Chinese Medicine and crystal-based medications is of paramount importance to treat the cause of Blood stagnation and formation of Blood clot leading to high D-dimer and not just treating the symptoms, that it is the formation of blood clot itself.
