## How Laser Typesetting-Printing is Proofing that Light Photons Leading Edge Speeds have First Origin Dependant Velocities V2.3

#### ABSTRACT

#### $V_{\text{total,observed}} = C + E_{\text{arth orbital speed}};$


This means Fizeous light speed measurement needed a greater speed of light than C, actually C + orbital speed of the Earth to

The two knife edge chopped laser beams are pointed into an oblique opposing-standing mirror box causing a long interrnal reflected winding light beam cylinder having a stacked-reflected-undulating light beam length of over 1000 meters, this is emphasising-pronouncing any difference in beam speeds, if present, in differential arrival times. These two side by side light beams having each a differential-separate-real electron mass-motion-photon source; now we can measure-quantize the end positon differential or simultaineous arrival time after the over 1000 meter run through the light-beam cylinder and evaluate, within the laboratory, the chromatic properties, the leading edges arrival timing differentials of the two exit light beam pulses from the mirror box light cylinders entering two side by side electrical solar cell sensors, comparing the differential or simultaineous arrival timing with an "and -or and electronic delay lines within an electronic circuit" in the nanosecond realm identifying-proving the reality of Einstein's simultaneity light theory or Newton's corpuscle light theory!
